

## **Ken Odom Memorial River City Pistol Regional 2700 An NRA Registered Tournament With CMP "Leg" Match**

Date: September 29, 2021, Evansville, Indiana

Sponsor: Daniel Boone Gun Club--Located on the North side of Hwy 62, 4 miles East of 1-164 (Exit 9)  
GPS/Mapping address - 8401 State Route 62 W, Chandler, IN 47610 (NOT a mailing address!)

Eligibility: All competitors must be familiar with range procedures and NRA rules.

Rules: Current NRA Conventional Pistol Rules will govern this Tournament

Awards: Cash awards furnished by Sponsor.

Classification: NRA classification system, all competitors shoot as civilians in OPEN class. Scores may be reported in other equipment classes by request in advance of competition and inspection to assure compliance with class rules.

Challenge Fee: \$1 per challenge returned if challenge is sustained.

Entry Closing: Entries close at the beginning of firing each day. **No late Entry Fee**

Fees: \$50 package includes NRA Registration Fee & Grand Agg. Individual Aggregates: \$20 Per Agg plus NRA Registration fee of \$8. Make checks payable to: **Gene Hall**

Registration: Registration and target assignment begins at 7:30 AM (CDT or EST) each day. "2700" begins at **8:30 AM (CDT/EST)** each day, followed by the Distinguished Revolver Match, followed by the "Leg" Matches

Firing Schedule: One (1) relay of 24 competitors. Grand Aggregate shooters get preference.

Award Schedule: Highest scoring competitor in each Match shall be declared the Winner and will not be Eligible for class awards. 1 award for each class that has at least 3 Competitors, 2 awards for 6 and 3 awards for 9. Classes that have less than 3 competitors will be combined with the next higher Class.

Special Notice: An NRA Distinguished Revolver Match will follow immediately after the 2700 each day. Separate entry required, \$10 entry fee. Course of fire: National Match Course. Equipment: per NRA rules.

### **Special Notes:**

1. Competitors must score and change targets.
2. Bring your own drinks, no potable water on the range, bottled water available.
3. Awards made at the range if possible, otherwise they will be mailed.
4. Use of all scoring aids (except overlays) is restricted to range personnel.
5. Use of eye and ear protection is required.
6. **Light lunch served by the Club at no charge. Bring your own drinks.**

**When: Sept 26, 2021 Match to be fired after the "2700" --1 relay of up to 24 shooters in each class. There must be at least six non-distinguished shooters to make a match.**

**Course of Fire: National Match Course (30 shots)**

Stage 1: 10 shots slow fire, 50 yards, 10 min time limit

Stage 2: Timed fire, 2 five shot strings, 20 sec per string

Stage 3: Rapid fire, 2 five shot strings, 10 sec per string

**Open To All Eligible Participants. Need not be a member of the NRA or a CMP affiliated club to participate. Eligibility is as defined in CMP Rules, Section 4. Affidavit must be on file with sponsoring club or CMP. Distinguished Shooters may enter, priority is given to non-distinguished competitors.**

**Fees: \$20 per class, separate entry required, matches fired separately**

**Firearms Allowed: "Service Pistol" as defined in the current CMP Rule Book, Rule 6.2.**

**Firearms Allowed: "Standard Small Bore Pistol, Caliber .22 Rimfire" as defined in the current CMP Rule Book, Rule 6.3.**

**Ammunition: As defined in Rule 6.4.2**

**Awards: EIC points toward Distinguished Pistol Shot Badge or Distinguished .22 Rimfire Pistol Badge, as appropriate. All awards and points issued by the CMP.**

**Rules: Current edition of the CMP regulations governing Excellence in Competition Matches.**
